# Response to application for permission for meteorological measurements and sampling at Sieidečearru in Anárjaohka National Park - University of Eastern Finland

The Anárjohka national park board made a decision at the board meeting on 17. august 2021.

## **Decision**

The National Park Board of Anárjohka National Park provides the University of Eastern Finland, permission to continue existing measurements and upgrade instruments at one of two measuring stations at Sieidečearru in Anárjohka Álbmotmeahcci / Anárjohka National Park. Permission is also granted to take non-destructive samples of lichen and other plants.

## Terms:

- The permit is valid for the years 2021 up to and including 2024.
- The work should be done as gently as possible.
- If rare and endangered plant species are detected in the area, the station or sampling must not affect the species in question.
- The National Park Board must have submitted results / reports from the project.
- When the installation has been upgraded, the national park board will be sent pictures of this.
- All traces of the upgrade work must be removed.
- All tracks at both stations will be removed when the project ends.

The National Park Board invites researchers to present their results when they are available.

#### Note:

This dispensation is granted in accordance with the Biodiversity Act and the Conservation Regulations for Anárjohka National Park. If there is a need for permission after another legislation (eg the Motor Traffic Act after municipal dispensation), from landowners or other bodies, the developer must take care of this himself.

## Right of appeal

The decision can be appealed to the Norwegian Environment Agency within 3 weeks, cf. the Public Administration Act §§ 28 and 29. The appeal must be in writing and substantiated and sent to the County Governor of Finnmark, cf. the Public Administration Act § 32.
